BURIAL OPENINGS:

Grave Opening.....	\$ 850.00 (Monday thru Friday)
	\$1,050.00 (Saturdays)
 Mausoleum Opening.....	\$ 700.00 (Monday thru Friday)
	\$ 900.00 (Saturdays)
Cremation Opening.....	\$ 450.00 (Monday thru Friday)
(In-ground & niches)	\$ 650.00 (Saturdays)

Note: Openings are scheduled before 1:30 PM on weekdays and before 12noon on Saturdays. Openings arriving later than 1:30 PM on weekdays or later than 12 noon on Saturdays, will incur overtime fees at a rate of \$300 per hour pro-rated per 15 minutes beginning 1:45 PM weekdays and pro-rated per 15 minutes beginning 12:15 PM on Saturdays.

An additional \$200 "recording fee" applies when a family is interring/entombing a second person at the same time of the initial opening, such as cremains placed inside the casket.

Holiday Opening \$900, based on three hours of overtime, plus the opening fee
 Grave opening – holiday: \$900 plus \$850 – total: \$1,750
 Mausoleum opening – holiday: \$900 plus \$700 – total: \$1,600

DISINTERMENT (in-ground)

Grave.....	\$1,500.00
Cremains.....	\$ 600.00

DISENTOMBMENT: (mausoleum/columbarium)

Crypt.....	\$1,250.00
Niche.....	\$ 500.00

Note: Disinterments and disentombments require a permit. Additional fees may also apply. Please inquire at cemetery office. Replacement of crypt front: \$500 single / \$900 double. Removal of headstone: fee based on size and disposal cost.

PROPERTY RELEASE

The use of property is for the property owner or the property owner's relatives only and not for resale or profit. The rights of interment/entombment of an unoccupied property may be released only to St. Joseph's Cemetery & Mausoleums. A refund check is the amount paid, less perpetual care percentage and less the additional \$200 processing fee.

A notarized release form is required to release a grave, crypt, niche, and/or columbarium along with the original property deed. Release forms are available at the Cemetery Office.

TRANSFER OF PROPERTY (Includes new deed).....\$150.00

REPLACEMENT DEED.....\$75.00

HEADSTONES/MARKERS

Headstones and ground markers are purchased directly from a monument dealer. A list of area monument dealers is available at the Cemetery Office.

A **Foundation Permit** is required for all headstones and ground markers. The monument dealer will complete the permit and submit to the Cemetery Office for approval. All monuments must have a cross or religious etching. All headstones and ground markers require a concrete foundation base. All foundation work is done by the Cemetery. The fee for installing a concrete foundation is \$1.75 per square inch except as outlined below. For example, a single headstone: 2'-6" x 1'-0" x 0.8" = 360 square inches x \$1.75 = \$630.00.

Babyland Markers (Size: not to exceed 8" x 14")..... \$150.00

Veteran Marker (Standard size 2' x 1').....\$200.00

The cemetery office stands ready to assist in processing the Dept. of Veterans Affairs application.
